The proposed development would not retain sufficient space within the combined curtilage of the public house and the proposed convenience store to accommodate the parking of all vehicles of customers and staff that would be expected to be at the public house and convenience store at any one time and that this deficiency would be likely to result in indescriminate parking of vehicles on the public highway in the vicinity of the site to the detriment of the safety and free passage of other road users, particularly on London Road which is an important and well-used local distributor road. Furthermore, the proposed arrangements for the delivery of goods to the proposed convenience store would both prevent access and egress to and from the majority of the

proposed car parking spaces and require delivery vehicles to either reverse into the site or reverse out onto London Road where such manoeuvres would present an unacceptable hazard to other road users. The proposal is therefore contrary to Adopted Plan Policies G1 and G6.

2. Insufficient information has been submitted which clearly demonstrates that the development and its future users will be safe over the lifetime of the development. The submitted Flood Risk Assessment does not fully address flood risks resulting from the development. The application is therefore contrary to the objectives of the NPPF (2012) which seeks to ensure that inappropriate development in areas of risk of flooding should be avoided by directing development away from areas at highest risk, but where development is necessary, making it safe without increasing the risk of flooding elsewhere.

(if applicable): The applicant's submitted information appears to be at conflict with the tacit response gained from the applicant at the site meeting where confirmation was given that prolonged breaks (periods of several months) occurred in the occupation of the caravans. An aerial photograph (image captured 2007) also questions the validity of the information that has been submitted by the applicant in such that it does not show the three caravans on the site. For these reasons the Council concludes that the evidence submitted is both imprecise and ambiguous. Based on the balance of probability the evidence submitted is inconclusive to determine whether the three caravans have been used continuously as residential caravans for a period in excess of 10 years prior to the date of this application.

(if applicable): The development will be approached by a narrow 2.6m access road that is to be widened to 4.1m by using a large part of the front garden area of no.100. The loss of this garden area as well as the poor relationship between the two existing dwellings and the proposed dwelling at the rear and the very narrow access track are all factors that when combined will have a detrimental impact on the character and appearance of the immediate area. No evidence has been submitted which clearly demonstrates that there is no longer a current need for this agricultural dwelling either on the holding or in the wider locality. On this basis this dwelling should continue to be available to meet that need. Removal of the condition would therefore be contrary to the NPPF (2012).
