SUMMARY

This report sets out the detail of the medium term financial strategy for the five years from 2020/21 to 2024/25, and the proposed budget and recommended level of Council Tax for 2020/21. This was presented to Cabinet on 19 February 2020, having been through scrutiny and consultation processes. The Council proposes to increase its element of the Council Tax by 2.05% to £192.96 at Band D.

RECOMMENDATIONS

1. To approve the Boston Borough Council Medium Term Financial Strategy for 2020/21 to 2024/25, and associated financial strategies which are appended at **Appendix C**.
2. To agree the formal 2020/21 Council Tax resolutions at **Appendix A** (Parishes, BTAC special expense, the County Council and Lincolnshire Police and Crime Commissioner are also dealt with as part of this resolution), that there is a 2.05% increase in the Borough element of Council Tax, its Band D Council Tax increasing to £192.96.
3. An increase in Council Tax premium on Long Term Empty Properties to apply the full extent of the provisions of the Rating (Property in Common Occupation) and Council Tax (Empty Dwellings) Act 2018:
 - An additional 50% Council Tax premium on Long Term Empty properties from 1 April 2020;
 - An additional 100% Council Tax premium on Long Term empty properties longer than 5 years, from 1 April 2020;
 - An additional 100% Council Tax premium on Long Term Empty properties longer than 10 years, from 1 April 2021.

The only exceptions to apply to the premium will be in respect of those empty properties that are already exempt under Council Tax legislation.

4. That the Council removes the current 10% second home discount from April 2020, increasing the Council Tax to 100% charge on furnished, unoccupied dwellings.

REASONS FOR RECOMMENDATIONS

The Council must, by law, set a balanced revenue budget while retaining sufficient resources to offset the impact of reasonably foreseen risks. The recommended budget and support measures are regarded as the most suitable approach.

ALTERNATIVES CONSIDERED

None.

REPORT

1.0 Purpose

- 1.1 The purpose of this report is to approve the budget and set the Council Tax for 2020/21, and to receive the Medium Term Financial Strategy (MTFS) to 2024/25.

2.0 Budget and Precept Levels

- 2.1 Following consultation and scrutiny, the Budget and MTFS were presented to Cabinet on 19 February 2020 which recommended their approval (with the subsequent confirmation of the final 2020/21 settlement figures by the government on 24 February), along with associated Strategies and Policies, to Full Council.
- 2.2 The final settlement advised by the Ministry for Housing, Communities and Local Government continues to give the Council significant challenges to ensure its budget is robust for 2020/21 and future years.
- 2.3 The Council currently estimates that it will need to find £1.421m to balance its budget by 2024/25, although the proposed changes to the funding regime from 2021/22 mean that significant uncertainties exist at present.
- 2.4 The capital programme for 2020/21 is £3.041m, and remains affordable, sustainable and prudent over the next five years. The programme includes £1.279m for replacement of the refuse vehicle fleet as a demonstration of the commitment to improving frontline services.
- 2.5 Treasury management and capital prudential indicators show the projected impact of capital expenditure and treasury investment plans. These have been reviewed by the Audit and Governance Committee.

2.6 **Section 151 Officer Statement:** Whilst I have mentioned some of the risks the Council faces going forward I am confident, as the Council's Section 151 Officer, that the budget will be delivered. I am also comfortable that at this present time the level of Council reserves is adequate.

2.7 This Council, as billing authority, is required to calculate a Council Tax requirement for the year. A glossary of terms is set out for reference at **Appendix B (2)**.

2.8 As part of the budget setting process, the precept levels of other Precepting bodies have been received. These are detailed below:

2.9 *Boston Borough Council Budget*

The Boston Borough Council budget was considered by Cabinet on 19 February 2020 and recommendations are now provided to Council on 2 March 2020, setting the Band D Council Tax at £192.96, a £3.87 (2.05%) increase on 2019/20.

2.10 *Special Area Expense*

The Boston Town Area Committee (BTAC) Special Area Expense for 2020/21 is detailed in **Appendix A** and totals £702,696. The increase in the average Band D Council Tax for Special Area Expense is 1.94% and results in an increase in the average Band D Council Tax figure of £1.44 for 2020/21.

2.11 *Parish Councils*

The Parish Council Precepts for 2020/21 are detailed in **Appendix A** and total £454,168.80. The increase in the average Band D Council Tax for Parish Council Precepts is 12.41% and results in an increase in the average Band D Council Tax figure of £5.04 for 2020/21.

2.12 *Lincolnshire County Council*

Lincolnshire County Council confirmed its precept for 2020/21 on 21 February 2020. The LCC Council Tax Requirement on the borough is £25,752,293.98. The estimated collection fund surplus is £57,334 giving rise to a County Precept of £25,809,627.98. This Council Tax Requirement represents a Council Tax Band D charge of £1,337.58 (an increase of 3.50%).

2.13 *Lincolnshire Police and Crime Commissioner*

The Lincolnshire Police and Crime Commissioner confirmed its precept for 2020/21 on 20 February 2020. The LPCC Council Tax Requirement on the borough is £4,839,601.47. The estimated collection fund surplus is £10,704 giving rise to a

LPCC Precept of £4,850,305.47. This Council Tax Requirement represents a Council Tax Band D charge of £251.37 (an increase of 4.14%).

3.0 CONCLUSION

- 3.1 The recommendations of the Cabinet are set out in the formal Council Tax Resolution in **Appendix A**.
- 3.2 If the Council Tax Resolution at **Appendix A** is approved, the total (average) 2020/21 Band D Council Tax position will be as follows:

2. Calculate that the Council Tax requirement for the Council's own purposes for 2020/21 (excluding Parish precepts) is £3,715,040.
3. That the following amounts be calculated for the year 2020/21 in accordance with Sections 30 to 36 of the Act:

(a) £41,571,849	being the aggregate of the amounts which the Council estimates for the items set out in Section 31A(2) of the Act (including Special Expense and Parish Precepts).
(b) (£36,699,945)	being the aggregate of the amounts which the Council estimates for the items set out in Section 31A(3) of the Act.
(c) £4,871,904	being the amount by which the aggregate at 3(a) above exceeds the aggregate at 3(b) above, calculated by the Council in accordance with Section 31A(4) of the Act as its Council Tax requirement for the year.
(d) £253.05	being the amount at 3(c) above, all divided by 1(a) above, calculated by the Council, in accordance with Section 31B of the Act, as the basic amount of its Council Tax for the year (including Parish precepts and Special Expenses).
(e) £1,156,864	being the aggregate amount of all special items (Parish precepts and Special Expenses) referred to in Section 34(1) of the Act (as per 1(b) above).
(f) £192.96	being the amount at 3(d) above less the result given by dividing the amount at 3(e) above by 1(a) above, calculated by the Council, in accordance with Section 34(2) of the Act, as the basic amount of its Council Tax for the year for dwellings in those parts of its area to which no Parish precept relates.
4. To note that the County Council and the Police and Crime Commissioner have issued precepts to the Council in accordance with Section 40 of the Local Government Finance Act 1992 for each category of dwellings in the Council's area as indicated in the table below.
5. That the Council, in accordance with Sections 30 and 36 of the Local Government Finance Act 1992, hereby sets the aggregate amounts shown in the tables below as the amounts of Council Tax for 2020/21 for each part of its area and for each of the categories of dwellings.

Methodology

Draft budget papers were made available online from 22nd January 2020 until 17th February 2020, for comment and consideration. Paper copies could also be requested by ringing the Municipal Buildings.

Full results

Q1 – Please read the draft Budget Report 2020/21 and the associated appendices. If you have any comments on the draft budget and what you feel the Council's priorities should be, please comment below:

1	Provide only essential services such as bin collections and cut others to reduce council tax.
