Some of the males on hearing this got aggressive towards officers and threatened to break people’s fingers if their caravans were touched. They also stated that if officers messed with them any further they would bring another 50 caravans and they would never leave the site.</p> <p>Police Sergeant attending liaised with Duty Inspector and decision was made not to revisit the site with officers of National Vehicle Crime Intelligence Service, but to await the court date before any further action was taken. Police detailed that they do not have adequate resources to deal with large disorder, which they believed was likely to happen.</p> <p>On receiving this update from the police, decision was made that no council officers would visit the site until after they had left or to serve further notice from the court after scheduled court hearing.</p>
