SUMMARY

This report sets out a proposal to seek approval to procure a crowdfunding partner to develop a S&ELCP Crowdfunding Scheme which will enable funds to be raised for community-based initiatives. This will enable each individual council to drive forward community funds. The initial set up cost is £34,000 and will be split between the three Councils of Boston Borough Council, East Lindsey District Council and South Holland District Council. Additional funding will then be proportioned from each council to promote projects within each geographical area.

The Boston scheme will be using £41,333 funds from the Empowering Healthy Communities Programme for 2022/2023.

Boston Borough Council will procure the service on behalf of the sovereign councils within the Partnership.

RECOMMENDATIONS

That:

1. Working with East Lindsey District Council and South Holland District Council as our partners in the South and East Lincolnshire Councils Partnership (S&ELCP), a Crowdfunding scheme be established.
2. Boston Borough Council contract with 'Spacehive' to provide external management of the scheme on behalf of the Councils.
3. Delegated authority be given to the Deputy Chief Executive – Communities and the Assistant Director for Wellbeing and Community Leadership, in consultation with the relevant Portfolio Holders across the Partnership, to agree final arrangements for the Crowdfund Scheme, including process, criteria and the awarding of grants.
4. A review of the benefits of the scheme be undertaken after an initial period of two years.

REASONS FOR RECOMMENDATIONS

Boston Borough Council is committed to empowering communities and increasing engagement and involvement across the whole of the Borough as it recovers from the effects of Covid-19.

Civic Crowdfunding aims to give residents and community groups the ability to attract funding from their communities, local authority and local businesses in an increasingly challenging financial environment. Crowdfunding allows local groups to develop a community project via an online public platform and then seek additional financial support through online pledges.

An opportunity to allocate funding to a community funding scheme (crowdfund) through the Empowering Healthy Communities Programme is available for 2022/23. This scheme would build on the success of the initial Councillor Grant scheme by allowing projects to gain further contributions from a larger pool of people and businesses via match funding.

The aim of the scheme is to support local projects and make communities stronger, more connected and more empowered by supporting projects that matter to them. This scheme will enable the Partnership to support the priorities of the local communities.

OTHER OPTIONS CONSIDERED

1. Not to establish a partnership Crowdfunding Scheme
2. Continuation of the existing Empowering Healthy Communities Councillor Grant Scheme for 2022/2023.

1. Background

- 1.1 Covid-19 has highlighted the critical importance of local government to their places and communities. Forging deep connections of understanding and relationship building, local government organisations are required to ensure community cohesion, resilience and community identity is nurtured, developed and well supported at a local level.
- 1.2 With the ability to combine resources and deliver cross-cutting community responses, the S&ELCP is best placed to align resources to address common challenges which face our communities and therefore have a greater impact.
- 1.3 Each sovereign council of the S&ELCP has set out the importance of its communities within their individual corporate plans.
- 1.4 If Members agree the development of a Crowdfund Scheme, Boston Borough Council would, on behalf of the Councils within the Partnership contract with Spacehive to provide Crowdfund Management.

Report

- 2.1 This section sets out an overview of Boston Borough Council's current Councillor Grant Scheme and how a Crowdfunding Scheme model would work in practice.

Boston Borough Council – Existing Councillor Grant Scheme

- 2.2 Boston Borough Council is delivering a significant Health and Wellbeing Programme (Empowering Healthy Communities (EHC) Programme) funded by DLUHC (formally MHCLG) Community Champions Programme.
- 2.3 A total of £494,800 was received in January 2021, which has enabled a wide-ranging programme to be developed.
- 2.4 In December 2021 Boston Borough Council was awarded an extension grant of £185,000 for Community Vaccine Champions, to build on the aims of original Community Champions programme
- 2.5 This EHC programme aims to help local areas diversity, enhance and accelerate community engagement opportunities, to support communities identified as being disproportionately at risk from Covid-19.
- 2.6 This additional funding received in December 2021 gives Boston the opportunity to review how best to support local community and voluntary groups.
- 2.7 As part of the EHC programme, a budget of £1,000 was made available (2021/2022) to each Boston Borough Council Member and £1,000 to each Parish Council in Boston Borough to enable the delivery of a Councillor Grant Scheme.

- 2.8 Prior to the Councillor Grant Scheme, there had been limited Borough Council funding to voluntary and community groups over recent years.
- 2.9 The EHC Councillor Grant Scheme has allowed small groups/communities to apply for funding of up to £1000 to support projects that meet the required criteria as set out as **Appendix A and B**. Applications have been assessed by the Empowering Healthy Communities Coordinator and a number of projects have been awarded funding, an overview is set out in **Appendix C**
- 2.10 As part of the 2022/23 Delivery Plan for the Community Champions funding, a budget has been allocated for a Healthy Communities Grant Scheme. Research indicates that using the fund to set up a Crowdfund scheme could potentially further increase the amount of funding made available for local community projects.

Civic Crowd Fund (Community Funding Scheme)

- 2.11 Crowdfunding is the process of allowing projects to advertise for funding. Schemes are primarily run online through social media and crowdfunding platforms, therefore providing maximum reach. This option is increasingly being used by a number of local authorities for example Cotswold District Council and Guildford Borough Council, as a way of financing community initiatives
- 2.12 Civic crowdfunding is becoming increasingly popular due to the numerous economic and social benefits it can deliver. Many local authorities across England have successfully used Crowdfunding platforms to engage with local residents and businesses to develop projects and seek financial support group online pledges to match local authority contributions. There are many benefits to exploring a civic crowdfund: -
- Ability to generate additional funds towards
 - Improving community capacity and resilience
 - Community engagement and involvement
 - Improved community cohesion and resilience
 - Improved transparency of decision-making
 - Improving awareness of issues that are important to local communities
 - Generating significant match funding by the 'crowd' for the benefit of the whole community, typically 3x what the local authority pledges.
- 2.13 It is proposed that a budget of £41,333 from the Empowering Healthy Communities Programme (externally funded) would be used to maximise this opportunity to support community projects and initiatives, and to develop a civic crowdfunding scheme.
- 2.14 The Crowdfund allows large groups of people to make small individual financial contributions to the projects. From research it is reasonable to estimate for every £1 the council invests into community projects through Crowdfunding it will result in an additional

£2.50 to £3 providing a 250%/300% expected return on investment. For example Cotswold Crowdfund has seen 19 funded projects in the first funding round, £300,000 has been raised so far with the Council pledging £93,000

- 2.15 The purpose of this report is to seek approval to award a provider to work with the South and East Lincolnshire Councils Partnership to develop a Civic Crowdfunding Scheme. The provider will bring both the technical expertise and the experience of crowdfunding in a local authority context.

Procurement

- 2.16 Spacehive is the only dedicated civic crowdfunding platform in the UK. While there are a number of other crowdfunding platforms, the majority are targeted on commercial investment.
- 2.17 Spacehive is the only dedicated civic crowdfunding platform provider on Government's G Cloud procurement framework, which enables a call-off on a competitive tender by the Council.
- 2.18 Spacehive was co-designed with local authorities and its platform provides bespoke technology especially created for council programmes. The aim of Spacehive is to make it as easy as possible for people with ideas to improve their local area by attracting support and funding from local people, local business and funders.
- 2.19 The platform contains in-built performance mechanisms that evidence the difference a project has made.
- 2.20 Spacehive is the only crowdfunding platform with a verification process, which ensures that projects will have the correct permissions and a clear budget in place before they can raise funds. This de-risk projects for the council and partners, also providing reassurance for others who want to pledge.
- 2.21 Over 40 local authorities are currently using Spacehive.
- 2.22 If a project achieves its funding target in the time allowed it proceeds and if it does not the project does not go ahead.
- 2.23 Further, detailed information about Spacehive is attached as **Appendix D**.

Timescales

- 2.24 The indicative timescale for implementation of the Crowdfunding Scheme would be 10-14 weeks, and the start-up costs are approximately £34,000 in total for the Partnership.

2.25 Boston will contribute a further **£30,000** to the Crowd Funding platform to match fund healthy community-based projects specifically in Boston Borough.

3. Conclusion

3.1 Crowdfunding presents a positive opportunity for Boston Borough Council to invest directly in the community, allowing for maximising of funds through match funding.

3.2 Projected outcomes of the project:-

- Evaluation of the benefits, issues and value of crowdfunding as a method of developing and supporting community led projects.
- Improved engagement with communities and support of projects that matter to the community
- Maximising Boston Borough Council funding for communities through match funding.
- Greater transparency in Boston Borough Council's support for community led projects.

3.3 Subject to the decisions at Boston Borough Council, East Lindsey District Council and South Holland District Council the Crowdfund will open for a funding round within 10-14 weeks.

4. EXPECTED BENEFITS TO THE PARTNERSHIP

4.1 Whilst the amount raised for community groups and projects cannot be guaranteed, examples from other areas show at least a 250%/300% return on investment for the community.

4.2 Running a Crowdfund across the S&ELCP will allow each sovereign council to maximise the opportunity to support community projects and initiatives,

IMPLICATIONS

5. SOUTH AND EAST LINCOLNSHIRE COUNCIL'S PARTNERSHIP

5.1 Managing a Crowdfunding Scheme as a Partnership approach will ensure resources are aligned for efficiencies, and that the benefits are maximised for all our communities.

6. CORPORATE PRIORITIES

6.1 The following Corporate Priorities are supported through the set-up of a Crowd Funding Scheme:

- Boston Borough Council – ‘Priority 1 - People Focused’
- East Lindsey District Council – ‘Maximise health and active lives’
- South Holland District Council – ‘Your health and wellbeing’

7 STAFFING

7.1 Utilisation of Spacehive to run the scheme would ensure that staffing resources across the partnership were minimalised however these would include contractual monitoring alongside payment authorisations. Some additional promotion of the scheme would be required which can be incorporated within existing resources.

8. CONSTITUTIONAL AND LEGAL IMPLICATIONS

8.1 The Localism Act 2011 includes a ‘general power of competence’. This gives local authorities the legal capacity to award grants for projects of benefit to the local community.

8.2 It is advised that Legal Services be asked to review the contractual arrangements and the process and criteria for the Crowdfunding Scheme. This is to ensure that these arrangements are robust, lawful and protect the Council from risk.

9. DATA PROTECTION

9.1 Spacehive is fully compliant with data protection law and the Data Protection Officer will be consulted during this project.

10. FINANCIAL

10.1 As detailed in section 2.24 the initial set up cost for the scheme across the Partnership is £34,000. With a further ‘funding pot’ contribution from each of the three councils. Boston Borough Council’s set up costs for 2022/23 will be met from the Empowering Healthy Communities Programme.

10.2 Further funding of £30,000 will be allocated to the Boston Crowd Fund from the Empowering Healthy Communities Programme in 2022/2023.

10.3 Subsequent annual cost of Spacehive is £34,000 split over the partnership, this would mean an ongoing cost for the life of the contract of £11,333.

11. RISK MANAGEMENT

11.1 None

12. STAKEHOLDER / CONSULTATION / TIMESCALES

12.1 It is estimated that the Crowdfund can be in operation within 10 to 14 weeks.

13. REPUTATION

13.1 A Crowdfund Scheme will have a positive impact on the reputation of the S&ELCP as it has the potential to maximise support to community projects and initiatives.

14. CONTRACTS

14.1 On behalf of the Councils within the partnership, Boston Borough Council will contract with Spacehive to provide a Civic Crowdfund and this will be closely monitored.

14.2 Having completed research it has been established Spacehive are the only Civic Crowdfunding Platform. Spacehive are on the Government's G Cloud 12 Procurement Framework, allowing the Council to enter into a contract with Spacehive through this Framework agreement.

14.3 The contract with Spacehive is a rolling annual contract. There is a break clause each year in the contract, should the Councils wish to exit earlier. The Scheme will be kept under review and officers will monitor the outcomes of the projects supported.

15. CRIME AND DISORDER

15.1 None

16. EQUALITY AND DIVERSITY/ HUMAN RIGHTS/ SAFEGUARDING

16.1 The establishment of a Crowdfunding platform does not have any identified disproportionate impacts on groups with protected characteristics. The following has been considered;

Good causes and groups

The Civic Crowdfunding platform provides a platform for local groups, charities and good causes to raise funds, many of which will support residents across a number of protected characteristics.

17. HEALTH AND WELL BEING

17.1 A Crowdfunding Scheme will enable support to be provided to community groups across the Borough to support communities with health, wellbeing, resilience, COVID recovery and wider issues.

18. CLIMATE CHANGE AND ENVIRONMENTAL IMPLICATIONS

18.1 There are opportunities to support local groups across a range of specialisms. These may include environmental groups that support our communities.
