




## RECORD OF OFFICER DELEGATED DECISIONS

TITLE:	Suspension of Car Parking Charges in the Council's <b>OFF STREET</b> Car Parks only for the periods set out in this Decision.
DECISION:	<p>To suspend parking charges in the Council's <b>OFF STREET</b> car parks only for the following periods:</p> <ul style="list-style-type: none"><li>• From 08:00 hrs on Friday 29 November 2024 to 18:00hrs on Sunday 1 December 2024;</li><li>• All day Saturday 7 December 2024</li><li>• All day Saturday 14 December 2024 and</li><li>• All day Saturday 21 December 2024.</li></ul> <p>Suspending parking charges in relation to this decision means providing '<b>FREE PARKING</b>' for the period prescribed above in the Council's <b>OFF STREET</b> car parks only in order to benefit local businesses and shoppers and to support the local economy and residents.</p> <p>Enforcement for non-payment of advertised fees will be suspended for the periods prescribed in this decision but ALL other parking contraventions, eg not parking within a designated bay, will continue to be enforced in accordance with the Council's Parking Order.</p> <p>For the avoidance of doubt, <b>NO</b> ticket will need to be obtained from any <b>OFF STREET</b> parking machine in the Council's <b>OFF STREET</b> car parks to qualify for 'free parking' during the prescribed periods.</p> <p>The <b>OFF STREET</b> car parks covered by this decision are:</p> <ul style="list-style-type: none"><li>• Bargate Green</li><li>• Custom House Quay</li><li>• Cattle Market</li><li>• Botolph Street</li><li>• Doughty Quay</li><li>• West End</li><li>• St George's Road</li><li>• Artillery Row</li><li>• Maud Street</li><li>• Buoy Yard</li><li>• Victoria Place</li><li>• Staniland</li><li>• George Street</li><li>• Spayne Road</li><li>• Tunnard Street</li></ul> <p><b><u>ON STREET Parking charges will remain at Pump Square, Market Place, South Square, Station Approach and Wide Bargate.</u></b></p> <p>No refunds of any tickets purchased during the prescribed periods, or App payments made will be eligible nor will there be any partial refund of any season ticket or other payments.</p>
