## CCTV Service Annual Statistical Report







### Introduction

This document provides an examination of data collected by the CCTV department for the CCTV areas within East Lindsey District Council, Boston Borough Council and South Holland District Council. This data is collected and studied to better understand the performance and achievements of the CCTV service. This report is not (nor indeed intended to be) a full picture of criminal activity within the areas it covers.

All CCTV camera areas within this report are monitored from the Boston CCTV control room. Towns and Parishes within the above districts that have alternative monitoring solutions are not included in this report. For example: the towns of Coningsby and Spilsby within the ELDC region have town centre CCTV systems that are not monitored by our control room, and therefore any incident data from those areas are not available to us.

Data for North Kesteven District Council in this report relates to the CCTV area of Sleaford which is monitored from the Boston CCTV control room.

The data presented in this report is primarily derived from the 'Viewscape' software (previously referred to as VTAS), which is utilised by the CCTV service.

### **Summary of Data**

The data within this report relates to the period between 01/04/24 and 31/03/25. Within this time period, CCTV operators have recorded:

13,374 Administrative Daily Log entries.

The Operators 'Daily Log' is a record of routine actions, such as marking the beginning and end of a work shift, routine camera patrols, radio & telephone communications and Control Room administrative duties.

An incident is an event or happening that deviates from the normal or expected course of events, often causing disruption, harm, or requiring attention or action. The CCTV incident log is a record of an Operator's actions and their assessment of the kind of incident they are involved with.

**442** CCTV contributed arrests. This breaks down further to:

A CCTV operator records police arrests for incidents that they have been involved with or arrests they have witnessed. This performs a safety function for all involved and also acts as an objective performance indicator.

A CCTV evidence package as produced by our CCTV Operators consists of a written witness statement and a DVD ROM disk of CCTV footage (sealed in an evidence bag for court use). Each evidence package takes a minimum of 30 minutes to produce but may take longer depending upon the complexity and volume of the footage. Flash drives or Hard Drives are sometimes used in evidential packages where bulk footage is requested.

### **Total Performance Data**

The chart below shows a monthly breakdown of the arrests, produced evidence, image reviews and arrests logged by CCTV across all monitored districts combined. This is compared with the figures from last year (23/24) and a percentage increase / decrease shown. The table on the page following shows a breakdown of the numbers by district.

Figures are highlighted red where there is an increase in logged incidents on the previous year, green where there is a decrease and yellow where it has remained the same.

**Image Reviews**. An image review refers to the process of a police officer or other authorised person viewing previously recorded CCTV footage in either the Boston CCTV Control Room or the CCTV Review Suites in Skegness, Mablethorpe and Spalding Police Stations to investigate a crime, anti-social behaviour, or other incidents.

\*The incidents in this section are those that were monitored live as they happened and logged by our CCTV Operators. Here we can see that some crime types (like Bicycle Theft) can be difficult for operators to spot unless the behaviour is particularly obvious. However, these incident types can be picked up at a later date by a review of recorded images.

Incidents are often covered by more than one camera to follow proceedings or cover the incident from multiple angles for better evidence capture. Therefore, adding up the columns will often produce a number higher than the total number of incidents logged.

#### **Conclusions**

It's encouraging to see a continued increase in the number of evidential packages produced during 2024-25. This trend is a clear indication that our upgrade strategy is delivering tangible results. Where financially viable, we've been enhancing camera installations by adding high-resolution static cameras to provide comprehensive recorded coverage, often achieving full 360-degree visibility. This significantly increases the likelihood of capturing incidents and, in turn, drives up the number of requests for evidential images.

In the past, our Image Review records too frequently included the phrase "nothing seen." Reducing this has been a long-standing goal, and we've made steady progress thanks to advances in more effective and affordable technology. Across the Partnership region, 61% of police CCTV image searches in 2024–25 resulted in evidential images—up from 58% in 2023–24 and 51% in 2022–23. While this upward trend is promising, we recognise there is still room for improvement. Where funding allows, we will continue to explore ways to push this percentage even higher.

However, this increase in evidence production does come with challenges, particularly the added pressure on CCTV staff. Each evidential package takes an average of 45 minutes to produce, which has the potential to divert resources from proactive monitoring. In practice, most Operators manage this by scheduling evidence production during quieter periods or multitasking where possible. Nonetheless, we will continue to monitor the situation closely to ensure that these higher levels of output remain sustainable with our current staffing levels.

In the meantime, we will continue to keep a dialogue with our end users to look at more efficient methods of evidence production and transfer. For the medium term, this will likely take the form of digital uploads directly to Lincolnshire Police through a digital evidence management system. Similar methods could be used internally to provide evidence to ASB Officers, Environmental Enforcement Officers or any other department with the aim of achieving prosecutions through CCTV evidence.
